IZI-to B.V.COOKIE NOTICE

This cookie notice has been prepared with the aim of providing our website visitors with details regarding the technologies utilised on our website, as well as empowering our visitors to make informed decisions about how to manage cookies.

What is a cookie?

Whenever you visit our website, we place cookies onto your device for various purposes. A cookie is a small text-based file that is downloaded and stored on your computer, mobile, or similar device, containing information about your browsing activity on the website. They can, for example, be utilised to track the pages you visit on the website, store entered information, or remember your preferences, such as language settings.

Why do we use them?

We employ cookies to provide you with the complete functionality of the website, tailor your user experience, conduct analytics, and enhance our services.

Who is responsible for placing cookies on our website?

All cookies have a publisher that identifies who the cookie belongs to. Some cookies are placed on the websites by us; these are known as “first-party cookies”. Others are placed on the website by another organisation, with our approval. These cookies are referred to as “third-party cookies”.

IZI-to B.V, Deventerlaan 31, 3528AG, Utrecht, the Netherlands, and the named publisher, listed in the cookie subgroup in the cookie list below, are both responsible for setting cookies on your device when you access any of our official websites and for the access and collection of data from the same device.

For how long are cookies stored?

Cookies can be stored for different durations on your browser or device. Temporary cookies, also known as session cookies, remain on your device until you close your browser. Permanent cookies have an expiration date, and once this date has passed, the cookie is deleted when you revisit the website that generated it.

What types of cookies do we use?

We utilise four categories of cookies: strictly necessary, performance, functional, and marketing. Only the latter three categories require user consent. For strictly necessary cookies, user consent is not required, as these cookies ensure the uninterrupted display of website content, allowing users to access the website and receive an appropriate digital browsing and online experience.

How to accept or withdraw your cookie consent in “Cookie settings”?

You can manage your cookie preferences in the “Cookie Settings” section located at the bottom of this website. You have the option to accept all three categories of cookies or only select one if you prefer. By agreeing to a cookie category, you consent to all cookies within that category (refer to the detailed cookie list below). You can adjust your preferences and reject cookies at any time within the Cookie Settings.

If you choose not to use cookies on your device, you can control your preferences by deselecting it in the list of cookie categories in the “Cookie Settings” section. Please note that such changes may impact the functionality of the website and could limit personalised offers or advertisements available to you.

Furthermore, in addition to withdrawing your consent, you can prevent your browser from accepting cookies by adjusting your browser's cookie settings. Most commercial web browsers offer cookie management functionality. Consult your web browser's settings to learn more about deleting or disabling cookies.

If you opt to “Accept All Cookies”, you agree to all cookie categories and acknowledge that we may share this information with third parties, including our advertising partners. This may involve processing your data outside the EU/EEA in certain cases. Choosing “Only required cookies” means that only cookies classified as “strictly necessary” will be placed on your device. You can disable cookies that are not strictly necessary for the website to function at any time by withdrawing your consent.
